Duncan Bonner, managing director and co-owner of ITB Competence Assurance, described the collaboration as a perfect coming together of expertise. He said: "Safety continues to be at the core of everything our customers do, particularly in sectors such as oil and gas, renewables and maritime. In 2019, the oil and gas industry alone experienced 25 fatalities during 3bn work hours. While this was down 19% on the 31 fatalities recorded the previous year, even one fatality is one too many. Ensuring competence across the workforce is a route to achieving a zero fatality rate.

"Our agreement with Mintra combines unrivalled expertise in the field of competence management services, bringing together two highly skilled and complementary teams of people, focused on ensuring customers have access to industry leading tools and services."
